Please refer to this office's letter of even No. dated 05.10.2023 regarding 'Selection Criteria for Nomination of OEPs as Sending Organization for Japan under MoC on TITP'.

2. In the view of above referred letter, this office has finalized the terms of the Phase-IV of the selection criteria wherein it has eased some benchmarks in order to promote overseas employment and to provide opportunity to a greater number of OEPs under TITP, Japan.

3. The interested OEPs, who have not applied for TITP Japan previously, are requested to send their applications to BE&OE HQs along with the requisite information on their letterhead (*duly typed on given proforma at Annex-A (copy enclosed) along with documentary proofs*).

4. All previously received applications of the OEPs will be considered under the current drive too (Phase-IV). Hence, these OEPs are not required to send their applications again. However, they may send the documentary evidences (if any) regarding point 4 of criteria indicator i.e. 'Knowledge on Japan'. Moreover, the OEPs may also send supporting documents with respect to new development (if any) on 'Knowledge on Japan'.

5. The applications must reach BE&OE HQs latest by **October 12, 2023**, positively.
