Please refer to this office earlier letter No. BE-R (Stat) 1(107B)/2023 dated 05<sup>th</sup> October, 2023 on the subject cited above,

2. The criteria under Phase-IV of nomination of OEPs as sending organization for Japan under TITP was issued vide above mentioned letter to the all concerned including POEPA, PE offices and Ministry of OP&HRD for the information and circulation among the OEPs. The same was uploaded on BE&OE website for information of OEPs and general public.

3. All applications (224 in numbers) were scrutinized under the revised criteria (Phase-IV). The following table illustrates the total 34 OEPs who has met the minimum qualifying score (30%) to be nominated as sending organization for Japan by BE&OE:
